OPINION AND FINDINGS

By application filed September 16, 2013, Benstrans, Chadron, hereinafter referred to as Applicant, seeks a Certificate of Public Convenience and Necessity to operate as a common carrier of passengers by motor vehicle as follows:

AUTHORITY SOUGHT

Transportation of passengers by van between points in Dawes, Box Butte, Sheridan and Sioux counties, and between points in said counties, on the one hand, and on the other hand, points in Nebraska over irregular routes. All trips to originate in the said counties. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: Yes.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on October 21, 2013, pursuant to the rules of the Commission.

protest was filed by Camelot Transportation, Inc., Grand Island. The protest was filed on October 25, 2013. Subsequent to the filing of the protest, the Protestant filed a Motion for Leave to Withdraw Protest and Withdrawal of Protest with the Commission.
