BY THE HEARING OFFICER:

On September 26, 2013, an application was filed Easy Access LLC, d/b/a Easy Access Transportation,, Omaha, Nebraska, seeking authority as a common carrier of passengers by van over irregular routes in Douglas, Sarpy, Cass and Lancaster counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized and the HHS Designation is Yes.

Protests were timely filed by Happy Cab, Yellow Cab, Checker Cab, DonMark, Inc., d/b/a Cornhusker Cab and Safeway Cab, all of Omaha, Nebraska, and by Transport Plus, Lincoln, Nebraska. A late-filed protest was received from Camelot Transportation, Kearney, Nebraska.

The Commission held a planning conference in this matter on July 1, 2014, and issued a Planning Conference Order and Notice of Hearing on July 7, 2014. The Order of July 7 set forth deadlines for discovery and depositions for the parties.

On September 8, 2014, the Protestants filed a Motion to Compel and Motion to Extend Deposition Deadline. On September 16, 2014, a telephonic conference was held with the following in attendance: Anthony Ike, attorney for the Applicant; Andy Pollock And Tara Paulson, attorneys for the Protestants; and Mark Breiner, Commission staff attorney.

Discussions were held regarding the Motion to Compel and to Extend Deposition Deadline. The Applicant requested that the hearing currently scheduled for September 24, 2014, should be continued to a later date. The Protestants did not object to the granting of a continuance.

As a result of the September 16 conference, the following agreements were made by the parties:

- 1. The Applicant will submit additional responses to the Protestants regarding the information sought in the Motion to Compel.
- 2. The deposition deadline, currently set for September 10, 2014, should be extended to October 1, 2014.
- 3. Witness lists and exhibit lists are to be exchanged by the parties on October 1, 2014.
- 4. That the hearing currently scheduled for September 24, 2014, should be continued to October 8, 2014.

Therefore, this order serves to memorialize those decisions and to provide a timeline for proceeding in this docket.
