OPINION AND FINDINGS

On September 26, 2017, the Commission entered an order granting the amended application of Dashabout Town Taxi, LLC (Dashabout), Akron, Colorado, to provide transportation services as a common carrier in taxi service in Scotts Bluff, Box Butte, and Kimball Counties over irregular routes. The Order included the steps that must be taken by Dashabout in order to be issued a Certificate of Public Convenience and Necessity, including payment of fees, registering vehicles, proof of insurance, and filing rates.

The Commission has attempted to assist Dashabout in completing these steps by phone, email, and letter. To date, Dashabout is still not in full compliance with the Commission's rules and regulations. Specifically, Dashabout has failed to provide proof of insurance, register any vehicles, pay required fees, and file rates.

After due consideration of the circumstances, the Commission finds that Dashabout Town Taxi, LLC, Akron, Colorado, should be ordered to show cause as to why its Application should not be dismissed for failure to comply with Commission Rules and Regulations. Therefore, hearing on this matter shall be held on Tuesday, October 2, 2018, at 11:00 a.m. in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
