BY THE COMMISSION:

OPINION AND FINDINGS

By application filed September 2, 2014, Yellow Cab Beatrice, Beatrice, sought to acquire, through transfer, the operating rights granted to Fairbury Taxi, Fairbury, in Certificate B-1668.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on September 4, 2014, pursuant to the rules of the Commission. Due to a clerical error on the Commission's part, the Daily Record notice indicated that there was an HHS Designation in the body of the certificate description, but the notice also contained a line that indicated that the HHS Designation of the certificate was No. The Certificate to be transferred had the HHS Designation of Yes.

The application was granted on October 15, 2014, with the HHS Designation erroneously listed as No. The Commission finds that the Order of October 15, 2014, and the resulting Certificate of Authority that was issued on January 15, 2015, should be clarified regarding the HHS Designation and that the HHS Designation should be listed as Yes.

The Commission finds that the Certificate of Authority in Supplement 1 of B-1874 should read as follows:

CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

COMMON: Transportation of passengers and their baggage by taxicab between points in Jefferson, Gage, Saline, and Thayer counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: Yes.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Certificate of Authority is hereby clarified and that the HHS Designation of Supplement 1 in B-1874, Supplement 1, be restored to read Yes; and that the Certificate will read as follows:
