O P I N I O N A N D F I N D I N G S

On September 12, 2016, EZ Cabs, Inc. ("Applicant"), Sioux City, Iowa, filed an application seeking authority to extend its authority in Dakota, Dixon, Cedar, Thurston, Burt, Cuming, and Wayne counties by adding a designation to provide transportation for the Nebraska Department of Health and Human Services. A timely protest was filed by Action Taxi and Limo, Inc.

On May 23, 2017, Applicant notified the Commission it no longer intended to pursue HHS designation and wished to withdraw its application.

After due consideration of the request and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant's request should be granted.
2. Application No. B-1894, Supplement 1, should be dismissed.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Applicant's motion to dismiss be, and it is hereby granted.

IT IS FURTHER ORDERED that Application B-1894, Supplement 1, be, and it is hereby, dismissed at Applicant's request.
