BY THE HEARING OFFICER:

On July 6, 2015, Crescent Transport, LLC (Applicant), Crescent, Iowa, filed an application seeking a Certificate of Public Convenience and Necessity to operate as a common carrier of passengers in vans in open class service, including clients of the Nebraska Department of Health and Human Services, between points in Nebraska over irregular routes. On July 13, 2015, a protest was filed by Golden Plains Services Inc. d/b/a/ GPS Transportation (GPS). On July 20, 2015, protests were filed by Kearney Cab Company (Kearney Cab) and Camelot Transportation Inc. (Camelot). Finally, on August 5, 2015, a protest was filed by Transport Plus of Lincoln, Inc. (Transport Plus) (collectively, Protestants).

On October 6, 2015, a telephonic planning conference was held to discuss a procedural schedule and hearing dates. Mark Breiner and Jamie Reyes represented the Commission, and the following persons participated via telephone: John Lingelbach of Koley Jessen on behalf of Crescent Transport; Jennifer Rowling of The Tye Law Firm on behalf of Kearney Cab; Jack Shultz of O'Neill Heinrich Damkroger Begmeyer and Shultz on behalf of GPS; and Andy Pollock of Rembolt Ludtke LLP on behalf of Camelot.

As a result of the planning conference, several issues were decided. Therefore, this order serves to memorialize those decisions and provide a timeline for proceeding in this docket. The Hearing Officer finds that the following schedule should be adopted:
