### OPINION AND FINDINGS

By application filed May 2, 2016, Leisure Party Bus & Limousine, Inc., Lincoln, hereinafter referred to as Applicant, seeks to operate as a common carrier of passengers by motor vehicle as follows:

#### CERTIFICATE SOUGHT

Transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on May 6, 2016, pursuant to the rules of the Commission.

Because no protests were filed, Application No. B-1928 will be processed pursuant to Rule 018.03 of the Rules of Procedure of the Commission.

The Commission's authority over common carriers in charter service is governed in part by federal law, which restricts States from enacting or enforcing any law, rule, regulation, standard, or other provision having the force and effect of law relating to the authority to provide intrastate or interstate charter bus transportation. Federal law further provides that States are not restricted from exercising safety regulatory authority with respect to motor vehicles, and may regulate motor carriers with regard to minimum amounts of financial responsibility relating to insurance requirements and self-insurance authorization.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is able properly to conform to applicable provisions of Neb. Rev. Stat. §§ 75-301 to 75-322 (Supp. 2015), and the

requirements, Rules and Regulations of the Commission thereunder.

2. Upon compliance with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates)(Supp. 2015), and with the rules and regulations of the Commission, a Certificate of Compliance should be issued as proposed:

### CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

Transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1928 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Compliance shall be issued to Leisure Party Bus & Limousine, Inc., Lincoln, in Application No. B-1928, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Compliance authorized by the Commission unless and until Applicant has fully complied, within ninety (90) days from the effective date of this Order, with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates)(Supp. 2015), and with the rules and regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Compliance is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
