BY THE COMMISSION:

On June 14, 2016, an application was filed by Fly Rydes Transport, LLC ("Applicant"), Scottsbluff, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by van between points in Scotts Bluff County, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their luggage is not authorized, and the HHS Designation is no.

The Commission has attempted to contact Applicant by mail and telephone regarding the pending application and the missing required background check information. Applicant has not contacted the Commission nor complied with the requirement to undergo a background check.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **October 14, 2016**, the Commission will dismiss the application for failure to take timely action.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by Fly Rydes Transport, LLC, Scottsbluff, in Application No. B-1932 be, and is hereby, set for **October 14, 2016**.
