OPINION AND FINDINGS

By application filed January 11, 2017, Rockstar Transportation ("Applicant"), Omaha, seeks to operate as a common carrier of passengers by motor vehicle as follows:

Transportation of passengers by bus in special party and charter between points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

Notice of the Application was published in The Daily Record, Omaha, Nebraska, on January 13, 2017. Because no protests were filed, the application will be processed pursuant to Rule 018.03 of the Commission Rules of Procedure.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

- Applicant is able properly to conform to applicable 1. provisions of Neb. Rev. Stat. §§ 75-301 to 75-322 (Supp. 2015), and the requirements, rules and regulations of the Commission thereunder.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1947 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Compliance shall be issued to Rockstar Transportation, Omaha, Nebraska, in Application No. B-1947, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Compliance authorized by the Commission unless and until Applicant has fully complied, within ninety (90) days from the effective date of this Order, with NEB. REV. STAT. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Supp. 2015), and with the Rules and Regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Compliance is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
