O P I N I O N   A N D   F I N D I N G S

On October 31, 2017, the Commission entered an order granting the application of Midwest Party Bus, LLC (Midwest), Omaha, formerly known as Elite Mobile Party Bus, to provide transportation services as a common carrier by bus in special party and charter service between all points in Nebraska over irregular routes. The Order included the steps that must be taken by Midwest in order to be issued a Certificate of Public Convenience and Necessity, including payment of fees, registering vehicles, proof of insurance, and filing rates.

The Commission has attempted to assist Midwest in completing these steps by phone and letter. To date, Midwest is still not in full compliance with the Commission's rules and regulations. Specifically, Midwest has failed to provide proof of insurance, register any vehicles, pay required fees, and file rates.

After due consideration of the circumstances, the Commission finds that Midwest Party Bus, LLC, Omaha, should be ordered to show cause as to why its Application should not be dismissed for failure to comply with Commission Rules and Regulations. Therefore, hearing on this matter shall be held on **Tuesday, October 2, 2018, at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.




