O P I N I O N A N D F I N D I N G S

On August 21, 2017, an application was filed by KMS Shuttle Service ("Applicant"), York, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by van in open class service between points in York, Lancaster, Hall, and Seward counties over irregular routes. The transportation of railroad train crews and their luggage is not authorized, and the HHS Designation is no.

The Application was granted on January 23, 2018. Applicant was provided with necessary information on how to complete the process to obtain the Certificate; however, Applicant failed to complete those steps. On June 19, 2018, the Commission entered an order to show cause as to why the Application should not be dismissed. On August 2, 2018, the Commission entered a second order rescheduling the hearing to September 18, 2018, to ensure service of the Applicant. The order was sent certified mail, return receipt requested, and it was returned as unclaimed.

Hearing was held on September 18, 2018, in the Commission Hearing Room. Ms. Ellie Rohr and Ms. Jamie Reyes appeared on behalf of Commission Staff. Applicant did not appear at the hearing. Mr. Rohr provided a brief statement outlining the steps the Department has taken to reach the Applicant, including the certified mail attempt, phone, and email. Applicant has been unresponsive. The Department recommended dismissing the Application.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds Applicant has failed to complete the necessary steps to obtain a certificate. Therefore, Application B-1959 should be dismissed.
