O P I N I O N A N D F I N D I N G S

On January 23, 2018, the Commission issued an order granting the Application of KMS Shuttle Service, LLC ("KMS"), York, to provide transportation services in open class between points in York, Lancaster, Hall, Seward, and Hamilton counties over irregular routes. The Order included the steps that must be taken by KMS in order to be issued a Certificate of Public Convenience and Necessity, including the payment of fees, proof of insurance, and filing rates.

The Commission has attempted to contact KMS by telephone and letter to detail requirements regarding the issuance of the Certificate. To date, KMS is still not in full Compliance with the Commission's rules and regulations. Specifically, KMS has failed to provide proof of insurance, register any vehicles, pay required fees, and file rates.

After due consideration of the circumstances, the Commission finds that KMS Shuttle Service, LLC, York, should be ordered to show cause as to why its Application should not be dismissed for failure to comply with the Commission's Rules and Regulations. Therefore, hearing on this matter shall be held on **July 25, 2018, at 10:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.


