O P I N I O N A N D F I N D I N G S

On November 28, 2017, the Commission entered an order granting the application of Exclusive Limousine (Exclusive), Lincoln, to acquire, by sale or transfer, the authority held by Exclusive Limousine, Lincoln, in Certificate B-1939. Exclusive complied with the necessary steps to receive their certificate and it was granted December 12, 2017.

On December 29, 2017, Exclusive's insurance carrier submitted a Form K indicating Exclusive's insurance would be cancelled as of February 1, 2018. Exclusive was able to obtain insurance effective January 31, 2018, and a Form E was submitted. On March 2, 2018, the Commission received a second Form K indicating the insurance would be cancelled effective April 2, 2018. Department staff contacted Exclusive. The owner, Sarah Foster, indicated she had moved and wished to transfer the Certificate. Department staff informed her the insurance must be in place to transfer and provided the forms she would need to begin the transfer process. After this conversation, the Department has been unable to reach anyone with Exclusive. Exclusive has continued to fail to have proper insurance on file.

After due consideration of the circumstances, the Commission finds that Exclusive Limousine, Lincoln, should be ordered to show cause as to why its Certificate should not be revoked for failure to maintain proper insurance. Therefore, hearing on this matter shall be held on **Tuesday, October 10, 2018, at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
