BY THE COMMISSION:

On January 3, 2018, an application was filed by CASHCAA, LLC, d/b/a 4 County Party Bus ("Applicant"), Broken Bow, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by bus in special party and charter between all points in Nebraska over irregular routes. The transportation of railroad train crews and their luggage is not authorized, and the HHS Designation is no. Notice of the Application was published in the Daily Record, Omaha, on January 11, 2018.

On March 6, 2018, the Commission entered an Order granting the Application. On August 28, 2018, the Commission entered an order of Pending Dismissal, as Applicant had not taken the necessary steps to receive its Certificate of Authority. Applicant was required to take action on the Application by September 18, 2018.

On September 17, 2018, Applicant contacted Department staff to request an extension of time. In its request, Applicant indicated that the insurance company required six months of CDL experience before issuing Applicant the required insurance. That time has nearly passed.

Based on the above, the Commission finds Applicant's request is reasonable and the request for an extension of time to comply with remaining application requirements should be granted. Action must be taken on this application by **Thursday, November 1, 2018**. Failure to take action by this date will result in dismissal of the application.




