OPININON AND FINDINGS

On November 19, 2007, Nebraska City Tourism and Commerce, Inc., Nebraska City, Nebraska, filed an application for authority to establish rates for its use in its operations as follows:

Note 1: On the above specials, the following is included: Driver in a tuxedo, Red Carpet rolled out at pick-up only, "Just Married"/"Happy Anniversary"/"Happy Birthday" signs are placed on the outside of the vehicle, and a disposable camera is included at no extra charge.

Note 2: Time begins when the trolley leaves the Syracuse garage and it ends when the party is dropped off.

Note 3: There is no weekend or holiday charge.

Note 4: All Trolley rentals do not include a tip or gratuity. We suggest a tip of 15% up to 20% of the rental amount. If the driver does not receive a tip, we can deduct that amount from the Security Deposit, if it is collected.

Note 5: On all Weddings, Anniversary and Birthday packages we do require a Security Deposit of \$100. This deposit can cover for any possible damages.

Note 6: On all trolley runs that go beyond a 25 mile radius of Syracuse, a \$65.00 Flat Empty Mileage Fuel/Insurance Surcharge will be assessed. There is unlimited mileage and stops during the rental time period.

Note 7: The Trolley is a "No Smoking" vehicle. If caught, the customer is warned once and the rental will be terminated immediately upon a second instance of smoking on the trip.

charters to originate and terminate in Nebraska City. SUPP. 1: Passengers in rubber-tired trolley cars in charter service originating and terminating in Nebraska City, whereby visitors, shoppers or residents of Nebraska City and surrounding counties are transported from Nebraska City to a specified location and returned to Nebraska City.

SUPPLEMENT 1: Transportation of passengers and their baggage by trolley in charter and special party originating within a 100 mile radius of Nebraska City, Nebraska.

The Applicant was placed under the temporary operating authority of DW & JW, Inc. on December 4, 2007. Under this arrangement the Applicant is now applying for an amendment to the rates allowed to be charged by the Applicant. The current rates held by the Applicant were last approved in 1990 and included only charges for individuals.

The new rates include rates for charters for special events such as weddings anniversaries and birthday, as well as charges for tours and special events. After discussion with Commission staff, the applicant agreed to withdraw any reference to tips or gratuities as set forth in original Note 4, and to change the location for beginning a trip and the fuel surcharge from Syracuse to Nebraska City. The Commission finds that the proposed rates as amended are reasonable and compensatory.

The Commission may grant an emergency application for rate amendments only if an emergency situation exists. In light of the recent temporary operating authority being granted and that the rates have not been adjusted since 1990, the Commission finds that such a situation does exist.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective December 14, 2007.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective December 14, 2007, Nebraska City Tourism and Commerce, Nebraska City,
