OPININON AND FINDINGS

On September 22, 2008, Omaha Fiesta Bus, Inc., Omaha, Nebraska, filed an application for authority to establish rates for its use in its operations as follows:

Description	Proposed Rates
Hourly Rental Rate (Exclusive use by client)	\$115/hour
Individual Seat Charge (Special events/weekend nights) (Separate charge from Hourly Rental Rate)	\$15/passenger

Emergency action is requested.

Applicant is a certificated common carrier which holds Permit B-1729. The certificate allows the Transportation of passengers and their baggage in special party bus between points in Douglas, Sarpy, Cass and Washington counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. HHS Designation: No. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.

The Applicant received authority to operate from the Commission under Certificate No. B-1729 on September 16, 2008. The Applicant is establishing its rates for use in this certificate.

The Applicant represents to the Commission that the proposed rate is based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective October 10, 2008.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective October 10, 2008, Omaha Fiesta Bus, Inc., Omaha, Nebraska, be, and it is hereby, authorized to establish rates for its use as follows:

Individual Seat Charge (Special events/weekend nights) (Separate charge from Hourly Rental Rate)	\$15/passenger
