BY THE COMMISSION:

On May 26, 2011, Todorovich Management d/b/a Starsky's, Omaha, Nebraska, filed an application for authority to establish rates for its use in its operations as follows:

Hourly rental rate (Exclusive use by client)	\$100/hour
Individual Seat Charge (Special events) (Separate charge from hourly rate)	\$2/passenger

Emergency action is requested.

### O P I N I O N   A N D   F I N D I N G S

Applicant is a certificated carrier which holds Certificate Number B-1792. The certificate authorizes the transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate Number B-1792 on June 1, 2011. The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the Application on an emergency basis.

The Commission further finds that the proposed rates are reasonable.
