OPINION AND FINDINGS

On January 22, 2014, Rockin N Rollin, LLC, Council Bluffs, Iowa, filed an application for authority to establish rates for its service as follows:

<u>Description</u>	<u>Proposed</u>
Friday and Saturday (4 hour minimum)	\$125/hour
Sunday through Thursday (4 hour minimum)	\$100/hour

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate Number B-1857. The certificate authorizes transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate Number B-1857 on January 7, 2014. The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges, as well as rates charged by other transportation companies providing a similar service.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an

emergency basis. The Commission further finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective January 31, 2014.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Rockin N Rollin, LLC, Council Bluffs, Iowa, be, and it is hereby, authorized to establish its rates on an emergency basis effective January 31, 2014, as follows:

Description	Rate
Friday and Saturday (4 hour minimum)	\$125/hour
Sunday through Thursday (4 hour minimum)	\$100/hour

IT IS FURTHER ORDERED by the Nebraska Public Service Commission that public notice of this action be published in the Daily Record, Omaha, Nebraska, pursuant to the provisions of Section 75-121, R.R.S. 2012, and the Commission rules.
