OPINION AND FINDINGS

On January 23, 2014, BWZ, LLC, d/b/a Playmakers Bar and Grill, Lincoln, filed an application for authority to establish its rates as follows:

Description	Proposed
Base Four Hour Rental within a 20 mile radius of Lincoln:	
\$600	
\$100 per hour added for any time over four hours.	
Base Four Hour Rental outside a 20 mile radius of Lincoln:	
\$675	
\$100 per hour added for any time over four hours.	
Wedding Party Special Three Hour Rental:	
\$300	
Minimum Two Hour rental for all bookings	
\$100 per hour for any extra time over rental.	
Emergency action is requested.	

Applicant is a certificated carrier which holds Certificate Number B-1851. The certificate authorizes transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate Number B-1851 on October 22, 2013. The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges, as well as rates charged by other transportation companies providing a similar service.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis. The Commission further finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective January 31, 2014.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service commission that BWZ, LLC, d/b/a Playmakers Bar and Grill, Lincoln, be, and it is hereby, authorized to amend its non-charter individual passenger service rates on an emergency basis effective January 31, 2014, as follows:
