OPINION AND FINDINGS

On May 29, 2014, Price's Party Patrol, LLC, Lexington, Nebraska, filed an application for authority to establish its rates as follows:

Description	Proposed
Per Hour (Two hour minimum)	\$150.00
Per Mile (100 mile minimum)	\$1.00/mi
Down Time (per hour)	\$40.00
Wedding Package (Two hours)	\$500.00
Day Rate (Six hours or more)	\$1,200

Promotional Programs to include either free mileage promotion, fifteen percent off the total rental price or book four hours and get a fifth hour free to be offered.

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate Number B-1797. The certificate authorizes transportation of transportation of passengers by limousine in a 50 mile radius of Lexington, Nebraska. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.

The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in

this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis. The Commission further finds that the proposed rates are reasonable.

The Commission finds that the promotional programs need to be placed in media in advance of the time period that the program will be in effect, and that any given promotion be of some duration detailed in the media. These conditions are placed upon the promotions so that the promotion does not become in effect a permanent discount off of the Applicant's rates, as well as for consumer certainty as to when and what trips the promotion is applicable to.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective June 13, 2014.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Price's Party Patrol, LLC, Lexington, Nebraska, be, and it is hereby, authorized to establish rates for its services on an emergency basis effective June, 2014, as follows:

Down Time (per hour)	\$40.00
Wedding Package (Two hours)	\$500.00
Day Rate (Six hours or more)	\$1,200

Promotional Programs to include either free mileage promotion, fifteen percent off the total rental price or book four hours and get a fifth hour free to be offered.

IT IS FURTHER ORDERED by the Nebraska Public Service Commission that public notice of this action be published in the Daily Record, Omaha, Nebraska, pursuant to the provisions of Section 75-121, R.R.S. 2012, and the Commission rules.


