OPINION AND FINDINGS

On October 28, 2014, Opulence Limousines, Inc., Lincoln, Nebraska, filed an application for authority to establish its rates as follows:

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate Number B-1875. The certificate authorizes the transportation of passengers by bus in charter and special party service in a 100 mile radius of Lincoln, Nebraska, over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No. The Certificate was granted on October 28, 2014.

The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an
