OPINION AND FINDINGS

On January 16, 2015, Shiloh Place, LLC, Fremont, Nebraska, filed an application for authority to establish its rates as follows:

Medical Transportation (one-way trip)	\$25.00
Outside of Fremont area:	
Wahoo (one-way trip)	\$50.00
Omaha (one-way trip)	\$100.00
Lincoln (one-way trip)	\$100.00

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate Number B-1888. The certificate authorizes the transportation of passengers by van between points in Dodge County, and between points in Dodge County, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: To be limited to the residents of Shiloh Place ALF. The transportation of railroad train crews and their baggage is not authorized. HHS Designation: Yes. The Certificate was granted on January 16, 2015.

The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon estimated expenses in insurance, gas, and staff time necessary to provide the transportation.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists

that allows the Commission to grant the application on an emergency basis. The Commission further finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective January 23, 2015.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Shiloh Place, LLC, Fremont, Nebraska, be, and it is hereby, authorized to establish rates for its services on an emergency basis effective January 23, 2015, as follows:
