OPINION AND FINDINGS

On March 6, 2015, Harmony Transportation Services, LLC, Omaha, Nebraska, filed an application for authority to establish its rates as follows:

Description	Proposed
Per Trip One-way for services in Douglas, Sarpy and Saunders Counties respectively	\$18.00

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate Number B-1878. The certificate authorizes the transportation of passengers by van in Douglas, Sarpy and Saunders counties, and between points in said counties. Restrictions: Transportation of passengers between points in said three counties, on the one hand, and points in any other county, on the other hand, is not authorized. The transportation of railroad train crews and their baggage is not authorized. HHS Designation: Yes. The Certificate was granted on March 10, 2015.

The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. The Commission finds that the proposed rate is reasonable and competitive.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 20, 2015.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Harmony Transportation Services, LLC, Omaha, Nebraska, be, and it is hereby, authorized to establish rates for its services on an emergency basis effective March 20, 2015, as follows:
