OPINION AND FINDINGS

Applicant is a certificated carrier which holds Certificate Number B-1901. The certificate authorizes the transportation of passengers by van in Lancaster County. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: Yes. The Certificate was granted on July 7, 2015.

The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges.
