## BY THE COMMISSION:

On September 9, 2015, the Commission granted Application No. B-1913, authorizing Adventure Enterprises, LLC (Applicant), Lincoln, to provide transportation of passengers by bus in special party and charter service between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and there is no HHS designation. Pursuant to the September 9, 2015 Order, Applicant is now seeking approval of its rates

On December 4, 2015, Applicant, filed an application for authority to establish its rates as follows:

Rates Per Mile	Proposed \$ 3.75
First 5 Hours (min.)	\$475.00
Per Hour After First 5 Hours	\$ 50.00
Multi-Day Chartered When Bus is Not in Service	\$600.00

CONDITION: Charges based on greater of per mile or hourly

Emergency action is requested.

Applicant is establishing its initial rates for use in this certificate. In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant does not currently have rates, and cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis. The Commission further finds that the proposed rates to be approved in this Order are reasonable.
