On December 24, 2015, Crescent Transport, LLC (Applicant), Crescent, Iowa, filed an application for authority to establish its rates as follows:

Round trip in a 30 mile radius	\$60.00/Trip
Each additional mile outside radius	\$2.00/Mile
One way trip in a 30 mile radius	\$32.00/Trip
Each additional mile outside radius	\$2.00/Mile
Personal attendant	\$20.00/Hour
Oxygen	\$25.00/Trip

Weekday hours are 6:00 a.m. - 6:00 p.m. Weekend rates are double.

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate No. B-1910. The certificate authorizes the transportation of passengers by van in Douglas, Sarpy, Lincoln, Dawson, Burt, Wayne, Washington, Dodge, Colfax, Lancaster, Cass, Saunders, Hall, Platte, and Otoe Counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is no. The Certificate was granted on February 23, 2016.

Applicant is establishing its rates for use in this Certificate. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such an emergency exists in

this application as Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 4, 2016.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Crescent Transport, LLC, Crescent, Iowa, be, and it is hereby, authorized to establish rates for its services on an emergency basis effective March 4, 2016, as follows:

One way trip in a 30 mile radius	\$32.00/Trip
Each additional mile outside radius	\$2.00/Mile
Personal attendant	\$20.00/Hour
Oxygen	\$25.00/Trip
