OPINION AND FINDINGS

On March 22, 2016, Caring People Sudan (Applicant), Omaha, filed an application for authority to amend its rates as follows:

Current Note: For all transportation that generates from Omaha to Lincoln, we charge \$75.00 per one way and \$150.00 per round trip. Transportation that generates from Omaha to Fremont, Nebraska City and Blair we charge \$75.00 per one way trip and \$100.00 per round trip.

Proposed Note: For all transportation that generates from Douglas and Sarpy Counties to any other city outside Omaha, Caring People Sudan will charge \$150.00 per person.

The application was published in <u>The Daily Record</u>, Omaha, Nebraska, on March 25, 2016. No protests to the application were received.

Applicant is a certificated carrier which holds Certificate Number B-1714. The certificate authorizes the transportation of passengers and their baggage by van for Employment First clients between points in Douglas and Sarpy counties, and between points in said counties where public transportation is not available due to bus line restrictions. Supplement 1 to the certificate authorizes the transportation of passengers and their baggage by van for the Nebraska Department of Health and Human Services clients between points in Douglas and Sarpy counties, between points in said county, on the one hand and, on the other points in Nebraska over irregular routes. transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is yes. The Certificate was granted on March 12, 2009. Supplement 1 to the original authorization was granted on October 28, 2009.

Applicant is seeking to amend its current rates due to budgetary increases, such as the addition of new vehicles and insurance. Applicant states its current rates have been in use since 2010. The Commission finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted effective May 27, 2016.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Caring People Sudan, Omaha, be, and it is hereby, authorized to amend rates for its services as follows:
