OPINION AND FINDINGS

On March 22, 2016, Papio Transport Service, Inc. (Applicant), Papillion, filed an application for authority to amend its rates as follows:

The application was published in The Daily Record, Omaha, Nebraska, on March 30, 2016. No protests to the application were received.

Applicant is a certificated carrier which holds Certificate Number B-1733. The certificate authorizes the transportation of passengers in open class service over irregular routes between points in Douglas and Sarpy counties and between points in said counties. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is yes. The Certificate was granted on April 21, 2009.

Applicant is seeking to amend its current rate from \$32.00 for the first thirteen miles to \$32.00 for the first five miles per trip one way. Applicant is also seeking to increase its additional mileage charge from \$1.66 to \$1.75 per mile.

Applicant states that it is seeking to amend its rates to be at the competitive rate of other companies in the Douglas and Sarpy county areas. The Commission finds that the proposed rates are reasonable.
