Applicant is a certificated carrier which holds Certificate Number B-1877. The certificate authorizes the transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No. The Certificate was granted on August 26, 2014.

The Applicant is amending its rates for use in this certificate with the addition of a Sunday through Thursday discount of twenty percent off the Saturday charge, a new charge for smoking if done on the bus, and a reduction in the per mile charge from \$1.75 per mile to \$1.00 per mile. The Applicant is also seeking a new special party bus rate of \$20.00 per person round trip for a Wine Festival.

The Commission finds that the proposed rates are reasonable. The rates for the larger bus are competitive with other carriers providing a similar service, and the proposed mileage rate is also competitive with similar rates by other providers.

In applications such as these, the Commission must find that an emergency situation exists. An emergency exists in this situation as the Applicant should be placed in a position to take advantage of the proposed rates for the benefit of its operations. Therefore, the Commission finds that a basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective May 6, 2016.
