On July 14, 2016, The Wine Bus, Gibbon, ("Applicant"), filed an application for authority to establish its rates as follows:

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate No. B-1931. The certificate authorizes the transportation of passengers by bus in Charter and Special Party service in Buffalo County over irregular routes. The transportation of railroad train crews and their baggage is not authorized. Applicant will not be offering limousine and/or party bus service. The Certificate was granted on July 19, 2016.

Applicant is establishing its rates for use in this certificate. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such an emergency exists in this application as Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and
