On July 26, 2016, Nightlife Party Bus, LLC ("Applicant"), Beatrice, filed an application for authority to establish its rates as follows:

Emergency action is requested.

Applicant is a certificated carrier which holds Certificate No. B-1934. The certificate authorizes the transportation of passengers by bus between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no. The Certificate was granted on August 2, 2016.

Applicant is establishing its initial rates for use in this certificate. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such an emergency exists in this application as Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.
