On November 4, 2016, Leisure Party Bus & Limousine, Inc. ("Applicant"), Lincoln, filed an application for authority to amend its rates as follows:

Emergency action is requested.

Applicant is a certificated carrier that holds Certificate No. B-1928. The certificate authorizes the transportation of passengers by bus between all points in Nebraska. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no.

Applicant is seeking to amend its rates based upon customer feedback regarding its current rate structure and customer needs. The proposed rate structure would eliminate the current regular, wedding, and special event rates and instead use an hourly rate. Additionally, the proposed additional hourly rate after four hours would be decreased. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant cannot begin using the new rate structure until the Commission approves the application. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective November 21, 2016.

#### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Leisure Party Bus & Limousine, Inc., Lincoln, be, and it is hereby, authorized to amend rates for its services on an emergency basis effective November 21, 2016, as follows:
