On November 10, 2016, Papio Transport Service, Inc. ("Applicant"), Papillion, filed an application for authority to amend its rates as follows:

Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 12, 2016. No protests were filed.

Applicant is a certificated carrier that holds Certificate No. B-1733. The certificate authorizes the transportation of passengers in open class service over irregular routes between points in Douglas and Sarpy counties and between points in said counties. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is yes. The Certificate was granted on April 21, 2009.

Applicant is seeking to amend its current rate of \$32.00 for the first five miles per trip one way to \$37.00 per trip one way. Applicant would no longer assess a mileage charge.

Applicant states that it is seeking to amend its rates to be competitive with other companies that operate in Douglas and Sarpy counties. The Commission finds that the proposed rates are reasonable.
