O P I N I O N   A N D   F I N D I N G S

On November 22, 2016, Kelly DeSive ("Applicant"), O'Neill, filed an application for authority to establish its rates, which was amended on May 19, 2017 as follows:

<u>Description</u>	<u>Proposed Rates</u>
Per Mile Rate	\$1.66/mile
Nebraska Personal Care Assistant (PAS) Rate	\$2.30/quarter hour
Wait Time	\$2.38/quarter hour
Per mile rate calculated by prorating to the nearest mile when odometer at .05 or more	

Emergency action is requested.

Applicant is a common carrier whose authority was approved in Application No. B-1925 on August 30, 2016. The Application approved the transportation of passengers by sedan between points in Holt and Boyd counties, and between points in said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is yes.

Applicant is seeking to establish its initial rates for use with its certificate of authority. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant should be placed in a position to take advantage of its new rates and begin operations as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.
