On December 30, 2016, Meltech, Inc. ("Applicant"), Lincoln, filed an application for authority to establish its rates as follows:

Description	Proposed
Hourly Rate (if pick-up and drop off location is inside Hastings city limits)	\$100/hour
Flat Fee (if pick-up and drop-off location is outside Hastings city limits)	\$60/person, 10 person minimum

Emergency action is requested.

Applicant is a certificated carrier that holds Certificate Number B-1943. The certificate authorizes the transportation of passengers by bus and van in special party and charter between points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no.

Applicant is seeking to establish its initial rates for use with its Certificate. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant cannot begin operations until the Commission approves the application. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective January 10, 2017.

Description	Rate
Hourly Rate (if pick-up and drop off location is inside Hastings city limits)	\$100/hour
Flat Fee (if pick-up and drop-off location is outside Hastings city limits)	\$60/person, 10 person minimum
