OPINION AND FINDINGS

On May 4, 2017, Standfast Transportation, Inc. ("Applicant"), Omaha, filed an application for authority to amend its rates as follows:

Notice of the Application was published in $\underline{\text{The Daily}}$ $\underline{\text{Record}}$, Omaha, Nebraska, on May 9, 2017. No protests were filed.

Applicant is a certificated common carrier which holds Certificate B-1747. The certificate authorizes transportation of passengers in Nebraska intrastate commerce to provide open class service by van between points in Douglas, Cass and Dodge counties over irregular routes. certificate includes the transportation of clients of the Nebraska Department of Health and Human Services. The certificate was issued August 5, 2010.

Applicant is seeking to reduce its per-trip rates within the City of Omaha. Applicant still plans to provide transportation for HHS, and Commission staff will work with HHS staff to ensure that Applicant receives the appropriate reimbursement amounts according to its proposed rate application. The Commission finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted effective June 27, 2017.
