Applicant is a certificated carrier which holds Certificate Number B-1877. The certificate authorizes the transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is no. The Certificate was granted on August 26, 2014.

Applicant is seeking to amend its rates with the addition of a new International Bus, an increase in the per mile charge from \$1.00 to \$1.75 per mile, and an increase in certain additional charges. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant should be placed in a position to take advantage of its new rates as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective July 11, 2017.
