On July 19, 2017, Three Sons, Inc. ("Applicant"), Malcolm, filed an application for authority to establish its rates as follows:

Emergency action is requested.

Applicant is a common carrier whose authority was approved in Application No. B-1955 on July 11, 2017. The Application approved the transportation of passengers by bus as a special party or charter in Lancaster, Seward, Gage, Saunders, Cass, and Butler counties on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is no.

Applicant is seeking to establish its initial rates for use with its certificate of authority. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant should be placed in a position to take advantage of its new rates and begin operations as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective July 25, 2017.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Three Sons, Inc. be, and it is hereby, authorized to establish rates for its services effective July 25, 2017, as follows:
