On August 18, 2017, Bar Crawler Party Bus ("Applicant"), Omaha, filed an application for authority to establish its rates as follows:

<u>Description</u>	<u>Proposed Rates</u>
Monday through Wednesday(2 hour minimum)	\$95.00/hour
Thursday and Sunday (2 hour Minimum)	\$115.00/hour
Friday and Saturday (4 hour minimum)	\$150.00/hour
Holidays (Minimums vary 2-8 hours)	\$175.00/hour

Emergency action is requested.

Applicant is a common carrier whose Application for authority was approved on July 11, 2017. The order authorizes the transportation of passengers and their baggage by bus in special party and charter between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no.

Applicant is seeking to establish its rates for initial use in its business. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant cannot receive its Certificate of Authority and begin operations until the Commission approves the application. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective September 6, 2017.



Holidays (Minimums vary 2-8 hours)	\$175.00/hour




