### BY THE COMMISSION:

On November 17, 2017, Rockstar Transportation ("Applicant"), Omaha, filed an application for authority to amend its published rates, which were granted on an emergency basis on November 28, 2017. Pursuant to Neb. Rev. Stat. § 75-121 and Commission rules, Applicant's rates were published in The Daily Record. Omaha, on November 30, 2017.

Subsequent to the granting of the rates, Applicant informed the Commission that the published rate schedule did not include a rate for Holiday Light Tours at \$250 for two hours, \$100 each hour after. Upon inspection, it was determined that the rate was included in the original rate application and was not included in either the November 28, 2017 order or The Daily Record publication.

# OPINION AND FINDINGS

The purpose of an order nunc pro tunc is to correct the record which has been made so that it will truly record the action taken which, through inadvertence or mistake, was not truly recorded. Clerical errors may be corrected by an order nunc pro tunc, but not judicial errors. 2

Based on the above, the Commission finds that an order nunc pro tunc should be entered. The November 28, 2017 Commission order granting Applicant's rates should be amended as follows:
