On November 17, 2017, Rockstar Transportation ("Applicant"), Omaha, filed an application for authority to amend its rates. Applicant's current rates are as follows:

Emergency action is requested.

Applicant is a certificated carrier that holds Certificate Number B-1947. The certificate authorizes the transportation of passengers by bus in special party and charter between points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no. The application for authority was granted on February 22, 2017, and its initial rates were established on the same date.

Applicant is seeking to amend its current rates for use with its Certificate to add rates for specific holidays and vary the charges for its base rates for certain days of the week. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant has stated that it would like to utilize the new rate structure for the upcoming holiday season. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective November 28, 2017.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Rockstar Transportation, Omaha, Nebraska be, and it is hereby, authorized to amend the rates for its services on an emergency basis effective November 28, 2017, as follows:
