On December 13, 2017, Red Star Transport, LLC, Atkinson, Nebraska, filed an application for authority to establish its rates for its use in its operations as follows:

O P I N I O N A N D F I N D I N G S

On March 6, 2018, Applicant was authorized in Application No. B-1963 to provide transportation of passengers by bus in special party and charter between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no.

Applicant is seeking to establish its initial published rates for use in its operations. Upon review, the Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant has received requests to provide transportation services and Applicant should be placed in a position to begin providing those services as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective April 9, 2019.


