Applicant is a certificated carrier that holds Certificate Number B-1799. Applicant is authorized to provide limousine services by luxury or stretch limousine, sedans, and SUVs, and special party and charter services within a 150-mile radius of Lincoln, Nebraska, between points within such radius on the one hand, and, on the other hand, points in Nebraska over irregular routes. Applicant's limousine authority was granted on March 6, 2012, and its special party and charter authority was granted on May 5, 2015.

In its application, Applicant is seeking to amend its rates for its stretch Hummer and party bus vehicles as well as its fuel surcharge for trips with a pick-up and/or drop-off outside of Lincoln. All other rates remain unchanged. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant cannot begin using the new rate structure until the Commission approves the application. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective July 24, 2018.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Tailored Dreams Limousine and Sedan Service, Lincoln, be, and is hereby, authorized to amend its rates for its services effective July 24, 2018 as provided herein.

IT IS FURTHER ORDERED that public notice of this action shall be published in The Daily Record, Omaha, Nebraska, pursuant to the provisions of Neb. Rev. Stat. § 75-121 and Commission Rules.
