OPINION AND FINDINGS

On August 22, 2018, All About You Party Bus, LLC ("Applicant"), Grand Island, filed an application for authority to establish its rates as follows:

Emergency action is requested.

Applicant was granted authority under Application Number B-1979 to transport passengers by bus in special party and charter between points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no.

Applicant is seeking to establish its initial published rates in order to provide transportation services for its clients. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application, as Applicant should be placed in a position to begin providing transportation services as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.
