On October 24, 2017, Applicant was authorized in Application No. B-1945 to Transportation of passengers by van in open class service between points in Douglas, Sarpy, Washington, Dodge, Cass, Saunders and Otoe Counties over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

Applicant is seeking to establish its initial published rates for use in its operations. Upon review, the Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant has received requests to provide transportation services and has entered into a services contract, and Applicant should be placed in a position to begin providing those services as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 26, 2019.
