Applicant is a certificated common carrier which holds Certificate B-1529. The certificate authorizes the transportation of passengers by limousine service, as distinguished from taxicab service, to and from points within Lancaster county on the one hand, and, on the other hand, to and from points within the state of Nebraska. Operations shall be on an appointment only basis with no regularly scheduled service to and from the Lincoln Municipal Airport.

According to the Applicant, the rates are based on expenses and are competitive with existing limousine/sedan services in the area utilizing similar equipment. The proposed rates are necessary to cover regular weekly and monthly maintenance expenses which include but are not limited to gas, tires, insurance, air conditioning repairs, license and taxes, upholstery and carpet cleaning, and general all around operating expenses plus replacement/update vehicle expense.

Applicant recently received its authority to operate limousines in Nebraska intrastate commerce. It currently does not have approved intrastate rates. The proposed rates are competitive with the rates on file for other limousine carriers whose authority includes the same area as the Applicant's and operating similar type equipment. The application is filed in compliance with Sections 75-308 (Rates) and 75-121 (Emergency rate orders), R.R.S. 1996 and the Commission rules.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective September 1, 2000.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective September 1, 2000, J.L.R.D. Inc., dba Lincoln Limousine, be, and it is hereby, authorized to establish limousine rates for its use as follows:
