OPINION AND FINDINGS

On September 19, 2000, Veronica Fiore, dba Affordable Limousine Service, Dakota City, Nebraska, filed an application for authority to amend its limousine rates as follows:

Description (Subject to Notes 1, 2, & 3)	Proposed Rate
A. Executive Sedan	\$45/hour
B. Six Passenger	50/hour
C. Eight Passenger	60/hour
D. Ten Passenger	70/hour
E. Fourteen Passenger	85/hour

Note 1: All service is subject to a two (2) hour minimum charge.

Note 2: Within the terminal area, time begins when the client is picked up and ends when the client releases the vehicle and driver.

Note 3: For service outside the terminal area; time begins when the vehicle and driver leave the garage and ends when the vehicle and driver return to the garage.

Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 21, 2000, pursuant to the Commission's rules. The application is unopposed.

Applicant is a certificated common carrier which holds Certificate B-1523. The certificate authorizes the transportation of passengers by luxury limousine between points within a 250-mile radius of Dakota City over irregular routes.

The Applicant states that it currently has a rate on file for a ten passenger limousine. Applicant has added different vehicles including a fourteen passenger limousine and an executive sedan for which rates have not been established. Applicant seeks to establish rates for the different limousine sizes and to modify the rate for the ten passenger limousine through an approximate 6.7% rate reduction. The Applicant further states that the proposed rates are based on expenses and that the proposed rates are competitive with other limousine companies in the area. The proposed rates are necessary to cover normal expenses which include but are not limited to fuel, tires, insurance, licenses, taxes, vehicle maintenance and general upkeep of the vehicles.

Applicant's current rate, which was for a ten passenger limousine, was authorized in May, 2000. Since adding an executive sedan and a fourteen passenger limousine, the ten passenger limousine rate was considered to high for the executive sedan and inadequate for the fourteen passenger limousine. The proposed rate for the different sized limousines are competitive with other limousine companies operating within the 250 mile radius of Dakota City.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted effective November 17, 2000.

## ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective November 17, 2000, Veronica Fiore, dba Affordable Limousine Service, Dakota City, Nebraska, be, and it is hereby, authorized to amend its limousine rates as follows:

Description (Subject to Notes 1, 2, & 3)	Rate
A. Executive Sedan	\$45/hour
B. Six Passenger	50/hour
C. Eight Passenger	60/hour
D. Ten Passenger	70/hour
E. Fourteen Passenger	85/hour

Note 1: All service is subject to a two (2) hour minimum charge.

Note 2: Within the terminal area, time begins when the client is picked up and ends when the client releases the vehicle and driver.

Note 3: For service outside the terminal area; time begins when the vehicle and driver leave the garage and ends when the vehicle and driver return to the garage.



