OPINION AND FINDINGS

On December 6, 2001, R & J Limo Services, Inc., Cozad, Nebraska, filed an application for authority to establish limousine rates for its use as follows:

Applicant is a certificated common carrier which holds Certificate B-1566. The certificate authorizes the transportation of passengers in limousine service between points in and west of Keya Paha, Rock, Loup, Garfield, Valley, Sherman, Buffalo, Kearney, and Franklin counties, and between points in said area on the one hand, and, on the other hand, points in Nebraska over irregular routes.

According to the Applicant, the proposed rates are based on expenses and are competitive with other passenger carriers in the area operating similar type equipment. The proposed rates are necessary to cover the cost of insurance, fuel, and vehicle maintenance. The proposed rates are believed to be sufficient to produce a reasonable profit and still maintain a quality service.

Applicant recently received its authority as a common carrier to provide a limousine service in a defined area which is roughly the western half of the state. The proposed rates are competitive with other limousine carriers providing a similar service with like equipment. The application is filed in compliance with Section 75-308 (Rates) and 75-121 (Emergency rate orders), R.R.S. 1996 and the Commission rules.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective December 21, 2001.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective December 21, 2001, R & J Limo Services, Inc., Cozad, Nebraska, be, and it is hereby, authorized to establish limousine rates for its use as follows:
