OPINION AND FINDINGS

On May 1, 2002, Tim Whitney, dba Tri-City Limousine Service, Kearney, Nebraska, filed an application for authority to establish rates for its use as follows:

Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate B-1567. The Certificate authorizes the transportation of passengers in Nebraska intrastate commerce to provide limousine service in luxury or stretch limousines between points in Buffalo County and between points in said county on the one hand and on the other hand points in Nebraska over irregular routes.

According to the Applicant, the proposed rates are based on projected income and expenses. The proposed rates are necessary to cover the cost of insurance, fuel, and vehicle maintenance. The proposed rates are believed to be sufficient to produce a reasonable profit and still maintain a quality service.

Applicant recently received authority to provide limousine service within its defined area. The proposed rate is competitive with other carriers providing a similar service with like equipment.
