On February 5, 2003, Extreme Limousine, Inc., dba A Limousine Service, Omaha, Nebraska, filed an application for authority to amend its limousine rates as follows:

The Applicant is a certificated common carrier which holds Certificate B-1561. The certificate authorizes the transportation of passengers by limousine between points in Douglas, Sarpy, Washington, Dodge, Lancaster, Cass and Saunders counties, and between points in said counties on the one hand, and on the other hand, points in Nebraska over irregular routes. The authority is restricted against transporting railroad train crews and clients of the Nebraska Department of Health and Human Services or subcontractors thereof.

According to the Applicant, a six-passenger limousine was recently purchased. The smaller limousine is in addition to the two SUV's currently in service. The proposed rates are necessary to cover the cost of insurance, fuel, vehicle maintenance, and still produce a reasonable profit. The additional vehicle, albeit smaller, will enhance the service available to customers.

The proposed rates are competitive with the rates on file and approved for use by competing limousine carriers operating similar type of vehicles in the Omaha metropolitan area. According to the Applicant, the proposed rates are based on its investment in the vehicles, and what it believes is necessary to recoup its investment.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

#### ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public. Service Commission that Extreme Limousine, Inc., dba A Limousine Service, Omaha, Nebraska, be, and it is hereby, authorized to amend its limousine rates as follows:
